## REPORT OF THE SUPERINTENDENT

Dr. Zelich announced to the Board that Charleroi Area School District was recently recognized as a top ten over performing District in the region according to the Pittsburgh Business Times. The rankings were released May 10 by the outlet, which has been ranking districts statewide for 15 years. Charleroi Area was ranked number 10 out of 106 regional school districts. The annual overachiever rankings are based on three years of standardized test scores of students in grades 3 through 11.
